This application serves for regular on-going consignment as well as holiday consignment. The winter holiday consignment period is November 1 of the current year through January 31 of the following year. Regular consignment will be granted for a period of six months initially, after which time it will be reviewed. Regular consignors may move to an on-going month-to-month arrangement that may be terminated by either party with thirty days notice. Please indicate the type of consignment for which you are applying. If you wish to apply for both, you must fill out two applications. If you wish to add holiday items and are already a consignor, please fill out an application for holiday consignment.

Jury dates will be listed at pARTiculars and may be obtained by calling the gallery. Jury procedures will be equivalent for regular as well as holiday consignment. For accepted pieces, artists must provide labeling in accordance with gallery guidelines which will be provided to you upon acceptance and before you deliver your work to be displayed.

Application Information:

Please list current/previous showings or galleries in which you have participated. Participation in galleries or shows is not a pre-requisite for art specifically designed for the holidays. (You may attach your resume)

Description of Products and Price Ranges: Please include all mediums and/or designs in your descriptions. (When pricing, remember the 50% commission.)

Please submit the completed application, plus **three to five pieces of your original artwork, along with the \$10.00 non-rundable application fee** when you deliver your work to be juried. Delivery of work will be accepted within a two day period prior to the jury date. Please do not bring work earlier unless you have made special arrangements.

The jury committee considers the following when looking at items:

- 1) Is it different from what is presently in the gallery? Please visit us to help yourself make this determination.
- 2) Is it unique and of good quality, and hand made? Accessories to pieces, such as a stand, do not have to be hand made.
- 3) Are the price points reasonable?
- 4) How well does the committee think the work will sell?
- 5) Will the size of he work fit into space at pARTiculars?

A jury committee member will contact you with results within forty-eight hours of the time the committee meets. Jury committee meetings are once a month: however, the date varies.

I hereby release pARTiculars, Art Gallery and Teaching Studio, LLC, and all its members from any responsibility or liability arising from applying for a consigning artist position, including damage to my artwork. I understand that accidents happen and that occasionally art work may be damaged. I also understand that pARTiculars will do everything possible to avoid any damage. I understand that this is an application and does not guarantee that my work will be placed at pARTiculars.
